 - Teaching appointments** : The researcher will carry out her/his teaching activity within the framework of the teachings relevant to SSD M-STO/09 (Palaeography), which are included in the Courses curricula offered by the Humanities Department. The researcher will also be required to assist students in writing the degree final test.
 - Scientific appointments:** The researcher will carry out his/her research activities within the framework of SSD M-STO/09 (Palaeography), also in connection with the other disciplinary fields of 11-A4 macro-sector (Book and Document Sciences), and in line with the objectives of the FARE Project "Il sogno della libertà. Scrivere in reclusione nell'Italia Moderna (secoli XV-XIX) - SCENIM" (Code R209BKEKNA). A commitment to the research internationalisation will be required, also through the elaboration of European competitive projects, and the involvement in both national and international networks
- **Rights and obligations:** as envisaged by the current legal provisions on the legal status of university researcher with fixed-term contracts and by the current code of ethics of the University ;
- **Duration:** 36 months non-renewable;
