- **Specific functions required to the research assistant:**
 - **Teaching duties:** in the context of teaching Sociology General (history and theory of sociology; social systems theory; methodology and techniques of social research; epistemology and modeling of social sciences; analysis strategies and presentation of sociological data; sociology of innovation; sociology of health, innovation, social equality, and sustainability, etc...). In particular, within the Bachelor's Degree Courses, Master's Degree Courses, and Doctoral Programs offered by the Department of Legal and Social Sciences, the School of Economic, Business, Legal and Social Sciences, and more generally of the University, with a focus on Chieti's campus;
 - **Scientific duties:** The candidate, as provided for by the declaration of the sector 14/G SPS-05, must possess the epistemological, theoretical, methodological, and historical foundations of sociology. These include the development of both quantitative and qualitative methodologies for data collection, processing, and interpretation; the design and implementation of surveys, interviews, and panel studies; biographical and case studies, as well as co-production of observations in case studies; the development of simulation models, scenario building, prevention, and monitoring of social phenomena; and the construction of strategies and guidelines for intervention;
 - **Third mission duties:** The candidate will demonstrate the ability to activate resources from the territory, promoting activities such as cultural initiatives and scientific dissemination (public engagement). Furthermore, they will be called to develop projects aimed at fostering economic and socially sustainable growth in the territory;
 - **Clinical care activity:** not expected;
 - **Time Commitment:** Full time;
