 - **Specific functions required to the research assistant:**
 - **Teaching duties:** in the courses framed in the academic discipline GIUR-05/A (Constitutional Law and Public Law) delivered within the degree and post-degree programs by the Department of Socio-Economic, Managerial and Statistical Studies, as well as in doctoral programs by the School of Advanced Studies of the University;
 - **Scientific duties:** The researcher shall carry out study and research activity regarding Constitutional Law and Public Law. He or she will develop a research project entitled “The processes of integration of legal systems in the European and global system”, in which the economic processes and their consequences on fundamental rights guarantee will be taken into account. He or she shall collaborate in organizing scientific conferences and seminars and prepare research proposals to apply for European and International research funding;
 - **Third mission duties:** The researcher commits to promoting and developing initiatives aimed at fostering the dissemination of scientific knowledge on the integration of legal systems within the European and global framework, also taking into account the dynamics of economic processes and the consequences of such phenomena on the protection of fundamental rights. This will be achieved, for example, through the organization and participation in conferences, seminars, and workshops aimed at a non-academic audience, the development of projects in collaboration with public and private entities, and through public engagement activities and support for public policy initiatives;
 - **Clinical care activity:** any clinical/care activity may be carried out following an agreement with the ASL (Local Health Authority) of Lanciano, Vasto, Chieti and/or the ASL (Local Health Authority) of Pescara and/or affiliated structures with the NHS (National Health Service), if there is the relevant availability in terms of vacancy of places in the agreement;
 - **Time Commitment:** Full time;
- **Rights and obligations:** as laid down by the provisions in force for the legal status of fixed term research assistants, and by the current Code of Ethics of the University;
- **Duration:** 72 months non-renewable;
- **Salary:** Euro 44.640,92 with application of the 20% increase equivalent to the remuneration due to the permanent researchers confirmed class high of 20%increase / as required by current legislation on the matter, and in particular by the D.P.R. 12/15/2011, n. 232 and subsequent economic adjustments provided by law;
- **Maximum number of publications:** 12 (twelve);
