INDEPENDENT WORK CONTRACT FOR HIGH-LEVEL PROFESSIONALS

VISITING PROFESSOR/RESEARCHER

Gabriele d'Annunzio University of Chieti-Pescara (hereinafter referred to as Ud'A), legally represented by the Rector, Prof. Liborio Stuppia

and

WHEREAS:

- Article 23 of Law no. 240 dated December 30, 2010;
- The Ud'A Statute, enacted by Rector's Decree no. 425 of 14/03/2012 - Official Gazette General Series no. 71 of 24/03/2012, as amended by R.D. no. 427 of 15/07/2013 - O.G. no. 174 of 26/07/2013, and by R.D. no. 74 of 17/01/2019 - O.G. no. 40 of 16/02/2019, and subsequent amendments and integrations.
- The University Regulation on Visiting Professor/Researcher and Fellow Mobility Programs, enacted by Rector's Decree no. 777 of March 21, 2018, and subsequent amendments and integrations.
- That by resolution of the Board of Administration dated, and of the Department Council of Y dated, the procedure for awarding the position of Visiting Professor/Researcher to Prof. X was approved.
- That the Rector, by Rector's Decree no. _____, conferred the position of Visiting Professor/Researcher to Prof. X at the Department of Y.
- Articles 26 and 27 of Consolidated Law no. 286/1998 and subsequent amendments regarding visa and reception matters.

THE PARTIES AGREE AND STIPULATE AS FOLLOWS:

Art. 1 – The preambles form an integral part of this contract.

Art. 2 – Prof. X (hereinafter referred to as “the Visiting Professor/Researcher”) agrees to perform the following activities on behalf of Ud'A: [...]

Art. 3 – The Visiting Professor/Researcher agrees to personally carry out the activities specified in this contract, for its full duration, without the use of substitutes.

Art. 4 – The Visiting Professor/Researcher agrees to complete the activities described in Article 2. Upon expiration, the contract will automatically terminate, without the need for explicit withdrawal.

Art. 5 – Upon completion of the contract, the Visiting Professor/Researcher will prepare a detailed final report on the activities carried out, which must be countersigned by the Ud'A Reference Professor and submitted for approval to the Department Head of Department.

Art. 6 – The Visiting Professor/Researcher will receive a flat-rate reimbursement of € per month. This amount will be paid in a single installment after the end of the visit.

Art. 7 – The University guarantees the Visiting Professor/Researcher civil liability insurance coverage. The Visiting Professor/Researcher is required to have adequate health insurance valid in Italy.

Art. 8 – The Visiting Professor/Researcher agrees to maintain confidentiality concerning data and information acquired during the execution of the contract.

Art. 9 – Either party may terminate this contract early for just cause. The Visiting Professor/Researcher may withdraw with at least 10 days' notice, without prejudice to the proper execution of the planned activities.

Art. 10 – An English translation of this contract is provided. In case of discrepancies, the Italian version shall prevail.

Art. 11 – The processing of the Visiting Professor/Researcher's personal data will be carried out in accordance with EU Regulation 679/2016.

Art. 12 – For any matters not explicitly covered, the contract shall be governed by the rules in Book V, Title III (Articles 2229–2238) of the Italian Civil Code.
