Objectives

Technology Transfer (TT) will represent a fundamental mission of the project, after the scientific research. Given the low TRL foreseen for the project, TT will have the role to accompany and scale up the research outcomes to an higher degree of maturation and industrial interests through the following specific actions:

- protection of research results;
- IPR management and exploitation;
- promotion and support for Spin-off creation;
- marketing and promotion of research results;
- building partnerships with companies and other institutions (public and/or private).

To reach this goal, a TT office with deep-in expertise in protection of new ideas/inventions, prior-art search for patentability, negotiation of licensing agreements and co-funded or commissioned research agreements, support in identifying financing opportunities and commercial partnerships, spin-off tutoring, and all other promotional activities for the exploitation of scientific results will be create. The TT office will work in close cooperation with other participating institutions' TT offices to promote synergic actions and monitoring of the efficacy of the consortium's TT actions.
