**RECALLED** the resolutions of the academic Senate and the Board of Directors in their respective organs meetings of 10/12/2019 and 17/12/2019 approved the awarding of 1 check of collaboration for research as reported in the table associated to this call;

## **DECREES**

### **ART. 1**

It's a competition, based on qualifications and job interview, for the assignment of no.1 check for collaboration in research activities as in Annex(1), in accordance with University regulations enacted with D.R.946 of 25/10/2011, edited by D.R. no.349 of 17/2/2012 and D.R. no. 1367 of the 22/9/2016 and D.R. n. 3586 del 03/08/2018 of the University"G. D'annunzio" of Chieti-Pescara.

The research activities and the related scientific results obtained in the frame of the check for collaboration in research will be evaluated by the Supervisor of the research activity through a report

describing the results obtained by the assignee. This report will be submitted for approval to Department Council or to the involved center, at the end of the check or at the request for renewal of the check.

The amount of the check, in accordance with D.M. n. 102/2011 is reported in the table in Annex(1) and it is gross of charges which will be submitted to the transferee check and University. The amount of the check will be adapted every year to the modulations of the social security and assistance rates.

The check will last 1 year renewable

### **ART. 2**

#### **General requirements for admission.**

Can participate in the contest:

- candidates that at the application deadline date have a Master degree obtained in Italy according to the actual regulations or according to the regulations before the D.M. 509/99.
- candidates that at the application deadline date have a degree (eg. Master) that in their country gives access to fourth-level studies (PhD) in one of the following fields of study: Physics or Engineering, or related field of study.

The PhD obtained in the scientific area of the research check, or other equivalent titles obtained in foreigner institutions are considered as a preferential title for the assignment of the check, according to the article 7.

To the selection cannot participate who are related or relationship or affinity to the fourth degree inclusive with a professor or researcher joined to the Department or structure that has requested the activation of the research check and where the research will take place or with the Rector or the General Manager or a member of the Board of Directors of the University.

For the identification of such subjects please refer to the information disclosed on the site [www.unich.it](http://www.unich.it) of the University.

Foreign citizens must hold a qualification recognized as equivalent referred to in point a) according to international agreements, or in the manner laid down in art. 332 of T.U. 31th august 1933, n.1592. Such equivalence should be by appropriate certification issued by the competent authorities, or may be declared, for the sole purpose of this competition, by the Committee referred to in art.7.

Who have been excluded from active political electorate is not entitled to be admitted to this proceeding.

Foreign citizens must possess the following requirements:

- a) civil and political rights in the States of belonging or origin;
- b) hold, except the ownership of Italian citizenship, all the other requirements laid down for citizens of the Republic;
- c) have adequate knowledge of Italian or English.

The requirements must be owned at the deadline date of the period prescribed in the notice of this competitive procedure for the submission of the application for admission.

Applicants are accepted on conditional basis whenever additional verifications are needed. If so, candidates must produce the required documentation within the established deadline, under penalty of exclusion.

The Administration may order, at all times, with a motivated order, the exclusion from collective fault standards.

### **ART. 3**

#### **Application and term**

The application for admission to the competition, will be drawn up on plain paper and in Italian or English and must be addressed and presented directly, or sent by registered letter with acknowledgement of receipt or sent by international courier to the Rector of University "G. D'annunzio" of Chieti-Pescara - Via dei Vestini no.31 - 66013 Chieti Scalo, within the deadline of **thirty (30) days** that shall run from the day following to its publication on the on-line Praetorian register of the University.

The application may be delivered:

this regulation. The validity of the transmission of the message sent by PEC will be assessed by the acceptance receipt and the delivery receipt provided by the legal professional association managing the PEC, according to art. 6 of the D.P.R. 11/02/2005 n. 68.

If sent by PEC, the application and the related a, digitally signed pursuant to Legislative Decree 7/3/2005 no.82<sup>1</sup> or signed by scanned handwritten signature, **shall be** in pdf format. *The maximum allowed PEC size is 50 MB.* If the attachment to be sent will be larger than this size, the candidate will have to send multiple PEC mails. The application will be sent in the first PEC mail, where the candidate will give notice that the attachments or part of them will be sent by one or more PEC mails following the first one, to be sent within the deadline for the application submission. As the subject of these additional mails, the candidate will write: "Addition to the application, the rectoral Decree number, the Department name, the title of the check, the scientific discipline".

The University Administration is not liable for the transmission of corrupted files through PEC.

**The applications sent after the deadline will be considered as unsubscribed and will be automatically rejected.**

### **Art. 7 Digital Signature**

*The digital signature ensures the identification of the author, document integrity and unmodifiability:*

1. Digitally sign electronic documents under art. 2 should refer clearly to a single subject and to the document or set of documents that is affixed or associated;

2. For generation of digital signing of electronic documents under art. 2, needs to do a certificate qualified that, at the time of subscription, is not expired or revoked or suspended.

3. Through the qualified certificate you need to detect the validity of the certificate, as well as the identification of the holder of the CA and any limitations of use.

The format of the documents sent by PEC shall be a static format which cannot be modified, not including macros and executables. The format will be possibly pdf.

**No account will be taken of questions delivered or mailed or submitted after the time limit set by this article.**

If the deadline falls in a public holiday, the deadline is postponed to the first working day after the holiday.

Unsubscribed applications or applications lacking of the candidate's personal data will not be considered in compliance with the law.

**Publication, titles and documents useful for the evaluation should be submitted according to the instructions given above and within the same deadline for the application submission.**

**In the applications sent through PEC, the rectoral Decree number, the title of the check, the Department name, the scientific discipline for which the interested party intends to participate. If omitted the issues mentioned above, in view of computer mishaps that may occur, the university Administration is not liable for the failure of the application.**

The applications must be written preferably according to the diagram annexed to this procedure (Annex A), including all the information which, according to the rules, the candidates are required to provide. The Administration is not liable for the loss of communications due to inaccurate indication of delivery by the competitor or no or late communication of change of the address indicated in the application, nor for any postal or telegraphic error, or for any responsibility of third parties, anyway due to unforeseeable circumstances or force majeure.

In the application, competitors must declare under their own responsibility, on penalty of exclusion from the competition procedure itself:

- 3) graduation possessed, the graduation vote as well as the date and the University at which it was obtained;
- 4) the PhD title, if possessed, as well as the date of achievement and the University where the course was held. Any diploma of specialization in the medical area, as well as the date of achievement and the University where it was obtained;
- 5) e mail address or PEC to be used for receiving communications regarding this contest procedure, or domicile or address with zip code, to be used for receiving communications regarding this contest procedure;
- 6) foreign citizens must also declare to enjoy civil and political rights in the State or country of origin, or the reasons for failure;, and that you have adequate knowledge of Italian;
- 7) their condition in relation to military obligations;
- 8) the **research check for which they compete;**
- 9) eligibility for participation as mentioned in art. 2;
- 10) the absence of relationship or affinity to the fourth degree inclusive with a professor or researcher in the Department or structure that has requested the activation and where the research will take place or with the Rector or the General Manager or a member of the Board of Directors of the University;
- 11) given the provisions of art. 22 co. 9 law 240/2010 which reads "the overall duration of relations established with the check awardees referred to in this article and of the contracts referred to in art. 24, occurred even with different public, non-public or telematic universities, or with state body in co.1 of this article, with the same person, cannot in any case exceed twelve (12) consecutive or non consecutive years . For the duration of these relations the periods spent on a leave of absence for maternity or for reasons of health are not included in accordance with current legislation". The competitor must declare whether the relations entertained with the entities mentioned in art. 22 under a research check or fixed term researcher contracts, indicating the transferor institution, the type of relationship and its exact duration;
- 12) to be aware that the "G. d'Annunzio " University of Chieti-Pescara will process the data contained in the application for the purpose of managing the competition procedure in compliance with the provisions of EU Regulation no. 679/2016, having read Annex E, which is an integral part of this announcement.
- 13) Declaration on being (or not) an employee of a public administration with data concerning the employment relationship:
  - ◆ a fixed term;
  - ◆ indefinitely;
  - ◆ parasubordinate work with contract.

Applicants with disabilities, in accordance with law 5th february 1992 no.104, must make a specific request, in relation to their handicap, about the assistance necessary to sustain the interview.

### **ART. 4**

#### **Qualifications and employment history**

In the application must be self-declared:

- a) Degree certificate obtained, or any equivalent qualification obtained abroad stating the vote reflected in the degree examination and its date and place;
- b) PhD certificate obtained, or any equivalent qualification obtained abroad;
- c) If obtained, specialization degree of medical area relevant to the sector concerned by the research check;
- d) If obtained, diplomas achieved in post-graduate courses attended in Italy or abroad

The application must also be accompanied by the following documents:

- 1) detailed curriculum of its scientific and professional activity which indicates the possible conduct of research activities in public and private subjects through contracts, scholarships or research assignments carried out both in Italy and abroad;
- 2) list of qualifications presented in the form of self-certification or in a copy conforming to the original mod. "B";
- 3) list of attached publications and relative description mod. "C";
- 4) self-certifications as required by attachment "B" of this announcement;
- 5) photocopy of an identity document and tax code. [The attachment of the photocopy of the document is mandatory.

In the case of relay through PEC you need to use the PDF format.

The Administration is required to carry out under 445/2000 sD.P.R. no.445/2000 suitable checks, including sample checks, and in any case where there are reasonable doubts about the veracity of the contents of the affidavits.

In the case of false declaration, candidate forfeits the benefits eventually achieved on the basis of misrepresentation, without prejudice to the provisions of the penal code and the related special laws.

Concerning the scientific publications, the candidate may enclose to the application the same through photocopies, together with appropriate declaration in lieu of an affidavit, in which certify their conformity to the original pursuant to Decree of the President of the Republic 28th December 2000, no. 445 or, alternatively, the same in PDF format stored on cd or other media.

It should be noted that are admitted to evaluate publications in press and in this case only if it is accompanied by the acceptance letter from the editor.

It is recalled that a general principle concerning competitions consists in that the titles to be evaluated must be clearly indicated by the candidate in the application, thus it is the candidate's burden to describe the obtained titles with such details suitable to allow the title evaluation.

**It's the candidate's burden to attach publications for evaluation by the Commission, if failing, the publications listed and not received will not be evaluated by the Commission.**

Candidates must provide, at their expense, within three months from the completion of the competition, to the recovery of the titles and any publications sent. After this period, the University will not be liable in any way for these publications and titles.

### **ART. 5**

#### **Prevention of overlapping, incompatibility**

Checks may not be combined with scholarships, whatever title conferred, except those granted by national or foreign institutions, which are useful to integrate with visits abroad, the research activity of the check holders. The ownership of the check is not compatible with attending graduate courses, master's degree or PhD degree scholarship (unless the student has already taken by the Faculty approval for doctoral thesis Defense) or courses of specialization in medical area, in Italy or abroad. The ownership involves, for the entire duration of the validity of the research grant, the placement on leave, without checks, for the employee employed by Government.

The staff at universities, research institutions and Government agencies for research and experimentation, the Italian National Agency for new technology, energy and sustainable economic development (ENEA) and the Italian Space Agency (ASI) as well as scientific institutions whose master has been recognized equivalent to a PhD in the fourth paragraph under article 74 of Decree of the President of the Republic 11th July, 1980, no.382 cannot be holders of the checks for collaboration in research activity.

The check holder may exceptionally carry out a limited self-employment activity, subject to authorization by the Council of the facility where the research activity is carried out, having heard the scientific manager certifying its compatibility with the research project and the absence of conflict of interest. The authorization must be transmitted to the competent offices of the Central Administration.

The check holder cannot hold university courses at the University or other public or private universities. He / she may be entrusted with limited educational, subsidiary or supplementary activity, in the topics related to the research grant, without charges charged to the University budget, within the total limit of 40 hours per contract reference year of the research grant. This activity will be certified by the Director of the Department issuing the check. The teaching activity carried out by the check holder cannot be counted in the time commitment made by the teacher who remains the holder of the teaching module.

The subsidiary or supplementary teaching activity delivered, within the specified limits, at the University Masters and Seminars can not entail charges on the University budget. The related remuneration

neration must exclusively be based on any possible external financing and not on the revenues deriving from subscriptions.

Subsidiary or supplementary teaching activities can also be carried out, within the specified limits, outside the University, and / or at public or private structures.

During the entire period in which the check holder performs his research activity, at the University he/she is covered by insurance relating to any accidents deriving from the activity carried out.

### **ART. 6**

#### **Board of examiners**

The Board of Examiners will be appointed by Decree of Rector, upon the proposal of the Department of Neuroscience Imaging and Clinical Sciences where the activities of check awarder will take place.

The Board will consist of three faculty members, of whom at least two must be professors of the scientific area of the research project or related areas. The Commission, if the Department or the involved institute considers it appropriate, may be supplemented by an additional non-member of University roles, experienced in the scientific research activities envisaged by checks.

At the end of its work, the Board will draw up the minutes containing the criteria for evaluations, the overall score awarded to each candidate, and the final ranking of merit.

### **ART. 7**

#### **Conduct of selection and criteria for evaluation of the titles**

Candidates must be provided with a valid identification document for access to the interview, on the day and at the place or should call to the skype address established and communicated. The selection is aimed at running a comparative evaluation of the candidacies proposed for the assignment of the research check, through an individual interview, and the evaluation of the scientific production and of the curriculum vitae and studiorum.

During the interview candidates may be asked questions relating to the subject matter of this announcement. The interview must aim at an evaluation carried out according to criteria which are open, effective, transparent, comparable at international level.

**The absence of the candidate, in the place or at the skype address communicated, is considered to be a definitive implied waiver for the selection.**

The ranking will be based on the overall score achieved by each candidate in the evaluation of scientific qualifications, the curriculum and the individual interview.

The Board of Examiners of selection must take into account:

- A)** titles and scientific publications, including: the PhD or equivalent qualification obtained abroad, the diploma of specialization in the medical area, the certificate of attendance for post-graduate specialization courses obtained in Italy or abroad, as well as a documented research activity in public and private subjects, through contracts, scholarships or appointments, both in Italy and abroad **(60 points at max out of 100)**.  
**20 points** are reserved for the **PhD qualification**, or equivalent, in the disciplinary sector concerning the research program provided for by the check or for the **Specialization** diploma of the Medical area.
- B)** the interview **(40 points at max out of 100)**. Candidates who have received less than 20/100 in the assessment of qualifications will not be admitted to the interview. Only candidates who have passed the aforementioned evaluation (20/100) will be promptly notified, with notice of days 20 natural and consecutive, about the convocation for the oral interview, in person or through videoconferencing, by registered mail a.r./pec and in advance by email. For speed requirements, the indicated term will in any case be calculated by advance notice via email. At this purpose it is advisable to indicate an email address currently in use. No communication will be sent to those who have not passed the aforementioned initial selection. The above will be acknowledged in the decree approving the deeds and winning appointment.

The selection procedures will end with the appointment of the winner and with the formation of a list of successful candidates up to a maximum of one year, whose use is bound to the specific needs indicated in the call.

### **ART. 8**

#### **Awarding of research checks.**

With the winners of this contest a treaty will be signed by the winner and the Rector of the University of Chieti-Pescara and the Tutor.

For non-EU citizen the effectiveness of the contract will be subject to the grant of authorization by the immigration Office at the competent Prefecture and shall be subject to condition subsequent of granting VISA to the winner.

With the conclusion of the contract the researcher assumes the rights and obligations provided for in article 10 of the Regulation and the University takes in respect of the researcher commitments under art. 11.

The assignee shall express their acceptance within ten (10) days following receipt of the formal communication subscribing the contract at the Central Administration Office – Staff Area.

In case of rejection, the research grant may be awarded to the next candidate on the list. If it is not possible to give the research grant for lack of ranking, the same can be banished again only once

within a time limit which would allow any new provision to the research grant before the end of the financial year.

The winner will be invited to self-certify the following statuses, facts and personal qualities:

- 1) date and place of birth;
- 2) the enjoyment of political rights;
- 3) not having criminal convictions; otherwise the winners will be required to self-certify the following convictions, the date of the judgment of the Court which issued it (although it's been granted amnesty, judicial pardon, remission, pardon, not mention etc, and although nothing is on criminal records. Criminal proceedings must be given whatever the nature thereof). Foreign citizens must declare that they have not criminal convictions in the State in which they are nationals and in the Italian one;
- 4) possession of tax code and the related number, VAT number and any data stored in the Archive of tax register relating to the same;
- 5) not having scholarships to any title conferred and not to be officials of the Institutions referred to in the first paragraph of art. 5 of this notice;
- 6) not being dependent of Public Administration with definite or indefinite employment contract or parasubordinate with the contract;
- 7) to have got the measure of expectation from the service at the Public Administration which is attached.

If the winner is affected by disability, they should be mentioned in the certificate, which must indicate whether these imperfections may reflect on the aptitude for collaboration in research activities. This certification must be dated no earlier than six months from the date of actual start date of collaborative activities.
