

INFORMATION ON THE PROCESSING OF PERSONAL DATA PURSUANT ACCORDING TO THE EUROPEAN REGULATION ON THE PROTECTION OF PERSONAL DATA (EU REG. 2016/679) - UPDATE

The G. D'Annunzio University of Chieti - Pescara is currently updating the information to be provided to data subjects, in accordance with the provisions of European Regulation 2016/679 on the protection of individuals with regard to the processing of personal data (hereinafter referred to more simply as "the Regulation").

During the necessary updating activity, all disclosures issued by any structure of the G. d'Annunzio University of Chieti - Pescara shall be supplemented by the following information

- any reference to European and national rules preceding the (and revoked by the) Regulation shall be considered to be replaced or supplemented by the rules of the same Regulation;
- in addition to what is indicated in the text of each specific informative note issued by the (single) structure of the University G. d'Annunzio of Chieti - Pescara, it is assured that all processing of personal data shall be adequate to the principles provided by the aforementioned Regulation, with particular attention to the lawfulness, correctness and transparency of the processing, to the use of data for specific, explicit, legitimate purposes, in a relevant way and in compliance with the principles of data minimisation, accuracy, storage limitation, integrity and confidentiality, accountability (art. 5 of the Regulation);
- in addition to what is indicated in the text of each specific information notice issued by the structures of the University G. d'Annunzio di Chieti - Pescara, data subjects have the right to request and obtain confirmation as to whether or not personal data concerning them are being processed, to be informed of the content and source of such data, as well as to be informed of the period for which the data are to be stored, the legal basis of the processing, the purposes and methods of the processing, the nature of the provision of the data, the possible communication of the data to non-EU States, the subjects to whom the data are communicated and their possible dissemination, and finally, and in general, the data subjects have the rights set out in sections 2, 3 and 4 of Chapter III of the Regulation (including the right to ask the data controller for access to their personal data, their rectification or suppression (under the circumstances) of the data; the right to object to the processing or request its limitation; the right to data portability; the right to submit a complaint with the Supervisory Authority.

In order to exercise their rights, the data subject may contact the data controller.

For the purposes of guaranteeing data protection and their rights with regard to processing, the data subject may contact the Data Protection Officer (DPO).
