**A comparative evaluation procedure for qualifications and public discussion has been launched for the recruitment of no. 1 full-time position as Researcher, according to Art. 24 co. 3 letter A) of the L 240/2010, S.C. 11/C5 History of Philosophy SSD M-FIL/07, History of Ancient Philosophy, activated for the study and research needs of the Department of Letters, Arts and Social Sciences;**

- **specific functions that the researcher is called to perform:**

**teaching commitment:** teaching activity within the SSD M-FIL / 07 and, in particular, the teaching of History of Ancient Philosophy in the course of study in Literature;

**scientific commitment:** research activity in the scientific-disciplinary sector of reference, with particular regard to the study of the genesis and development of Greek and Latin philosophical thought between the VI and VI AD, in its relations with the knowledge of the time through reflection criticism of the method of ancient philosophical historiography and an in-depth philological knowledge of the Greek-ancient and Latin texts, aimed at understanding the doctrines in historical-cultural contexts;

**rights and duties:** as foreseen by the current legal provisions on the legal status of the university researcher with a fixed term and by the current University ethical code;

- **contract duration:** 36 months and may be renewed for only two years upon the effective retrieval of the necessary economic resources, as approved by the C.di A.;

- **economic treatment:** it is equal to € 34,898.06 a.l. inclusive of the thirteenth installment, for the entire duration of the contract, corresponding to the remuneration due to the confirmed permanent researcher class 0, with full-time commitment regime (beyond the increases referred to in the Prime Ministerial Decree of 03/09/2019);

- **maximum number of publications:** 12 (twelve);

- **foreign language whose adequate knowledge will be assessed in relation to the University's multilingual profile or to the teaching needs of the study courses in a foreign language:** English or French;

- **methods of ascertaining the foreign language, or rather the knowledge of the Italian language for foreign candidates:** interview;

- **financial coverage:** departmental budget own funds;
